Case Presented by Doernenburg – there are 2 parcels adjacent to each other this request is to add 2 additional storage units, 40 x 120 each. This meets the zoning ordinance, parking in front of the units, snow storage in rear of units, Fire Chief review found no issues.

Nate Hall has stated that he has to deal with all the drainage from the other properties, the drain tile on the ditch causes all the water to flow down to his property, he has dealt with but it is costing him money and he would like to know if the problem could be fixed.
